## **Improving Childhood Immunization Rates**



Superior HealthPlan is committed to improving the health and quality of services provided to Medicaid (STAR, STAR Health, STAR Kids, STAR+PLUS), CHIP, STAR+PLUS Medicaid-Medicare Plan (MMP) and Ambetter members from Superior HealthPlan. This includes the appropriate administration of childhood immunizations. The National Committee for Quality Assurance (NCQA) Healthcare Effectiveness Data and Information Set (HEDIS®) performance improvement measure, Childhood Immunization Status (CIS), scores how successful providers are with administering all doses of the 10 recommended vaccines (Combo 10) by the child's second birthday. Combo 10 includes: 4 DTaP, 3 IPV, 3 Hib, 3 HEP B, 4 PCV, 1 HEP A, 1 MMR, 1 VZV, 2 or 3 RV and 2 Flu vaccine doses.

The Centers for Disease Control and Prevention (CDC) develop immunization schedules based on recommendations from the Advisory Committee on Immunization Practices (ACIP), the American Academy of Pediatrics (AAP) and the American Academy of Family Physicians (AAFP). The CDC schedules indicate specific timeframes for each dose. NCQA specifies ranges of time that each immunization is due. The NCQA time ranges capture the CDC timeframes; therefore, following this schedule when administering vaccines will meet the NCQA measurement.

Providers should utilize the following table to compare CDC timeframes and NCQA time ranges for the CIS immunizations, to ensure vaccines are administered appropriately.
