

## **Clinical Policy: Gilteritinib (Xospata)**

### Description

Gilteritinib (Xospata<sup>®</sup>) is a tyrosine kinase inhibitor.

### FDA Approved Indication(s)

Xospata is indicated for the treatment of adult patients who have relapsed or refractory acute myeloid leukemia (AML) with a FMS-like tyrosine kinase 3 (FLT3) mutation as detected by an FDA-approved test.

### **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Xospata is **medically necessary** when the following criteria are met:

## I. Initial Approval Criteria

A. Acute Myeloid Leukemia (must meet all):

- 1. Diagnosis of relapsed or refractory AML;
- 2. Prescribed by or in consultation with an oncologist or hematologist;
- 3. Age  $\geq$  18 years;
- 4. Documentation of a FLT3 mutation;
- 5. For Xospata requests, member must use generic gilteritinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
- 6. Request meets one of the following (a or b):\*
  - a. Dose does not exceed 120 mg (3 tablets) per day;
  - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

\*Prescribed regimen must be FDA-approved or recommended by NCCN

### Approval duration:

### **Medicaid/HIM** – 6 months

Commercial – 12 months or duration of request, whichever is less

### **B.** Myeloid/Lymphoid Neoplasm with Eosinophilia (off-label) (must meet all):

- 1. Diagnosis of a myeloid/lymphoid neoplasm with eosinophilia (MLNE) in chronic phase or blast phase;
- 2. Prescribed by or in consultation with an oncologist or hematologist;
- 3. Age  $\geq$  18 years;
- 4. Documentation of a FLT3 mutation;



- 5. For Xospata requests, member must use generic gilteritinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
- 6. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).\*
  \*Prescribed maximum must be EDA approved or recommanded by NCCN

\*Prescribed regimen must be FDA-approved or recommended by NCCN

## **Approval duration:**

Commercial – 12 months or duration of request, whichever is less

## C. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## **II.** Continued Therapy

## A. All Indications in Section I (must meet all):

- 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Xospata for a covered indication and has received this medication for at least 30 days;
- 2. Member is responding positively to therapy;
- 3. For Xospata requests, member must use generic gilteritinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
- 4. If request is for a dose increase, request meets one of the following (a or b):\*a. New dose does not exceed 120 mg (3 tablets) per day;
  - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
    \*Prescribed regimen must be FDA-approved or recommended by NCCN

## Approval duration:

## Medicaid/HIM – 12 months

**Commercial** – 12 months or duration of request, whichever is less



### **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

### III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents.
