Description

Omburtamab (Omblastys) is an anti-B7-H3 monoclonal antibody.

FDA Approved Indication(s) [Pending]

Omblastys is indicated for the treatment of relapsed or refractory high-risk neuroblastoma in patients aged 17 years and younger with central nervous system or leptomeningeal metastases.

Limitation(s) of use: [XXX]

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation® that Omblastys is medically **necessary** when the following criteria are met:

I. Initial Approval Criteria*

*Criteria will mirror the clinical information from the prescribing information once FDA-approved

A. Neuroblastoma (must meet all):

- 1. Diagnosis of high-risk neuroblastoma with central nervous system or leptomeningeal metastases;*
- 2. Prescribed by or in consultation with an oncologist;
- 3. Age \leq 17 years;*
- 4. Disease is relapsed/refractory after ≥ 2 lines of systemic therapy (see Appendix B);
- 5. Member has not yet received any doses of Omblastys (for members who have already received at least one dose, refer to the Continued Therapy Section II below);
- 6. Request meets one of the following (a or b):*
 - a. Dose does not exceed two doses of 50 mCi each, spaced four weeks apart;*
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).

*Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration: 3 months (2 doses only)



B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business:
 CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. II. Continued Therapy*

*Criteria will mirror the clinical information from the prescribing information once FDA-approved

A. Neuroblastoma (must meet all):

- 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Omblastys for a covered indication;
- 2. Member has received only one dose of Omblastys within the last 4 weeks and is in need of a second dose to complete the treatment regimen;
- 3. Member has not experienced any objective disease progression by week 5 after the first dose was administered.*
- 4. If request is for a dose increase, request meets one of the following (a or b):*
 - a. New dose does not exceed 50 mCi;*
 - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration: 1 month (1 dose only)

B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business:
 CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or



2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies—CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents.
