

# **Clinical Policy: Pimavanserin (Nuplazid)**

## Description

Pimavanserin (Nuplazid<sup>®</sup>) is an atypical antipsychotic.

## FDA Approved Indication(s)

Nuplazid is indicated for the treatment of hallucinations and delusions associated with Parkinson's disease psychosis.

## **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Nuplazid is **medically necessary** when the following criteria are met:

## I. Initial Approval Criteria

## A. Parkinson's Disease Psychosis (must meet all):

- 1. Diagnosis of hallucinations and delusions associated with Parkinson's disease psychosis;
- 2. Age  $\geq$  18 years;
- 3. Dose does not exceed 34 mg per day.

Approval duration: HIM/Medicaid – 12 months Commercial – Length of Benefit

## **B.** Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

## **II. Continued Therapy**

- A. Parkinson's Disease Psychosis (must meet all):
  - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - 2. Member is responding positively to therapy;
  - 3. If request is for a dose increase, new dose does not exceed 34 mg per day.

## HIM/Medicaid – 12 months Commercial – Length of Benefit

## **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.
  - Approval duration: Duration of request or 6 months (whichever is less); or
- 2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

## **III. Diagnoses/Indications for which coverage is NOT authorized:**

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace andCP.PMN.53 for Medicaid or evidence of coverage documents.
