Description

Clindamycin phosphate/benzoyl peroxide (BenzaClin®) is a topical combination product of two active ingredients: clindamycin phosphate, a lincosamide antibacterial agent, and benzoyl peroxide, an oxidizing agent with bactericidal and keratolytic effects.

FDA Approved Indication(s)

BenzaClin is indicated for the topical treatment of acne vulgaris.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that BenzaClin is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

- A. Acne Vulgaris (must meet all):
 - 1. Diagnosis of acne vulgaris;
 - 2. Age \geq 12 years;
 - 3. Medical justification supports inability to use the individual components (i.e., topical clindamycin phosphate, topical benzoyl peroxide) concurrently (e.g., contraindications to the excipients of all brand and generic products);
 - 4. Dose does not exceed 1 container per month.

Approval duration: 12 months

B. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

II. Continued Therapy

- A. Acne Vulgaris (must meet all):
 - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
 - 2. Member is responding positively to therapy;
 - 3. If request is for a dose increase, new dose does not exceed 1 container per month.

Approval duration: 12 months



B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – HIM.PHAR.21 for health insurance marketplace or evidence of coverage documents.

clindamycin phosphate 1% gel, lotion, solution (Cleocin T®); swab (Clindacin® P)	Apply a thin film to affected areas BID	Not applicable
benzoyl peroxide foam (BenzEFoam TM), gel, liquid, lotion [various strengths]	Apply topically to affected area QD; may increase to QID as needed	Not applicable

Therapeutic alternatives are listed as Brand name® (generic) when the drug is available by brand name only and generic (Brand name®) when the drug is available by both brand and generic.

Appendix C: Contraindications/Boxed Warnings

- Contraindication(s):
 - Hypersensitivity (e.g., anaphylaxis) to clindamycin, benzoyl peroxide, any components of the formulation, or lincomycin
 - o History of regional enteritis, ulcerative colitis, or antibiotic-associated colitis
- Boxed warning(s): none reported
