## **Description**

Mesalamine (Apriso®) is a locally-acting aminosalicylate.

## FDA Approved Indication(s)

Apriso is indicated for the maintenance of remission of ulcerative colitis in patients 18 years of age and older.

### Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Apriso is **medically necessary** when the following criteria are met:

## I. Initial Approval Criteria

- A. Ulcerative Colitis (must meet all):
  - 1. Diagnosis of ulcerative colitis;
  - 2. Age  $\geq$  18 years;
  - 3. Documentation supports inability to use mesalamine tablets (e.g., contraindications to the excipients);
  - 4. Dose does not exceed 1.5 g per day (4 capsules per day).

**Approval duration: 12 months** 

## B. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

## **II. Continued Therapy**

- A. Ulcerative Colitis (must meet all):
  - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - 2. Member is responding positively to therapy;
  - 3. If request is for a dose increase, new dose does not exceed 1.5 g per day (4 capsules per day).

**Approval duration: 12 months**

## **B.** Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

## Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace.

## III. Diagnoses/Indications for which coverage is NOT authorized:

**A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – HIM.PHAR.21 for health insurance marketplace.

mesalamine delayed-release	Ulcerative Colitis Lialda: 2.4 g to 4.8 g PO QD	4.8 g/day
tablet (Asacol <sup>®</sup> HD, Lialda <sup>®</sup> )	Asacol HD: 1600 mg PO TID for 6 weeks
